SS - 1 SECRETARIAL STANDARD ON MEETINGS OF THE ...

“Secretarial Auditor” means a Company Secretary in Practice or a firm of Company Secretary(ies) in Practice appointed in pursuance of the Act to conduct the secretarial audit of the company. “Secured Computer System” means computer hardware, software, and procedure that – (a) are reasonably secure from unauthorized access and misuse;
